

Purpose and Need

Project Purpose:

To provide safety and operational improvements at the intersection of Morris Street and Ridgedale Avenue.

Project Need:

- The intersection of Morris Street and Ridgedale Avenue ranked #11 in Morris County on NJTPA's 2023 Network Screening List.
- The October 2020 Road Safety Audit conducted along CR 510 (Morris Street and Washington Street) identified numerous deficiencies which contribute to a high crash rate within the project limits.

Existing Conditions

Morris Street (CR 510)

- Urban Principal Arterial
- Three Lanes Undivided (Two Eastbound)
- ADT approximately 22,000 vehicles
- Posted Speed Limit of 25 mph
- Ridgedale Avenue
 - Urban Minor Arterial
 - Four Lanes Undivided at Intersection
 - ADT approximately 14,000 vehicles
 - Posted Speed Limit of 25 mph







RSA Recommendations (October 2020)

- Upgrade curb ramps and driveway aprons for ADA compliance
- Traffic signal upgrades
 - ▶ 12" LED signal heads with retroreflective backplates
 - Countdown pedestrian signal heads
 - Audible PROWAG compliant push buttons
 - Investigate split phasing on Morris Street
- Investigate roadway lighting
- Pavement markings
 - Ladder style crosswalks
 - Restripe faded pavement markings
- Signing upgrades for MUTCD compliance
- Access management near intersection corners




Missing crosswalk for Ridgedale Avenue approach

Next Steps

- Complete Categorical Exclusion Document (Fall 2024)
- Complete Preliminary Engineering Phase (Fall/Early Winter 2024)
- Environmental Document Approval (Fall 2025)
- Begin Final Design (Winter 2026)
 - Revise concept plan based on stakeholder input
 - Prepare final plans, specifications, and engineer's estimate
 - Submit to NJDOT Local Aid for Federal Authorization
- Project Advertisement, Award, & Construction (2027)
