Division of Mental Health & Addiction Services - Ms. Gatica

- A. Funding Opportunities
 - 1. Nurse Care Management in Ambulatory Care Treatment
 - This Request for Proposals (RFP) is issued by the New Jersey Department of Human Services (DHS), Division of Mental Health and Addiction Services (DMHAS) to embed Nurse Care Managers (NCMs) into ambulatory substance use disorder (SUD) treatment agencies including Opioid Treatment Programs (OTPs), licensed outpatient, licensed intensive outpatient, and partial care to manage physical health services, including hepatitis C, for individuals being served at the agency. This RFP is funded through the Substance Abuse and Mental Health Services Administration's (SAMHSA) State Opioid Response (SOR) grant. The SOR grant period is from September 30, 2023, to September 29, 2024. Total annualized funding is up to \$1,660,000, with up to \$415,000 in annualized funding for each award; however, the contracts will be prorated for six (6) months, subject to federal appropriations. The goal of services is to focus on those who are at risk for or who have been diagnosed with hepatitis C. The NCM is expected to coordinate this treatment into the full array of services offered to each client served by the OTP. Successful bidders shall add nurse care management, case management, and health coaching to assist people with improving their overall health and well-being with an emphasis on hepatitis C and integration of their behavioral and medical healthcare.

- **b)** Proposals are due January 12, 2024; the Final award announcement is March 1, 2024.
- 2. Implementation of Coordinated Specialty Care & Community Integration Services for Early Serious Mental Illness
 - a) This Request for Proposals (RFP) is issued by the New Jersey Department of Human Services (DHS), Division of Mental Health and Addiction Services (DMHAS) for implementing Coordinated Specialty Care (CSC) programs for the population with Early Serious Mental Illness (ESMI) in New Jersey. In addition, the DMHAS will implement a Community Integration Program designed to address the ESMI population's needs along the continuum of care. DMHAS anticipates making up to six (6) awards for six provider agencies. The two programs will center on serving youths and adults ages 15 and older who have experienced psychotic symptoms. The CSC program will serve clients aged 15-35 for up to two years. The CSC-CI program will serve clients 15 years and older and allow patients to remain as long as needed based on the "Stepped Care treatment model". The New Jersey CSC and CSCCI programs will cover all 21 counties.
 - **b)** Proposals were due December 13, 2024; Final award announcement is February 8, 2024

- 1. Zero Suicide Institute Academies
 - a) There is an opportunity for mental health and substance use disorder treatment agencies to apply to attend one of two upcoming free, virtual Zero Suicide Institute Academies. These are two-day training courses for senior leaders of organizations that seek to prevent deaths by suicide among patients in their care. Using the Zero Suicide framework, you will learn how to incorporate best and promising practices into your organization's processes to improve care and safety for individuals at risk and to have the opportunity for follow-up consultation and technical assistance as your agency incorporates the practices. The Zero Suicide faculty will provide interactive presentations and small group sessions, collaborating with participants to develop organization-specific action plans.
 - b) Due to the holidays and an abbreviated time for recruitment, the New Jersey DHS-sponsored Zero Suicide December Academies were postponed and moved into early 2024. The first academy will take place on January 23-24 and the second on February 6-7. You do not need to resubmit if you have already applied to the previous dates. - 2. Governor Murphy announced on January 8, 2024, that he designed a bill to expand access to life-saving harm reduction services in New Jersey. The bill aims to provide more resources to harm reduction centers in the state that will be able to distribute Narcan, fentanyl test strips, etc.
